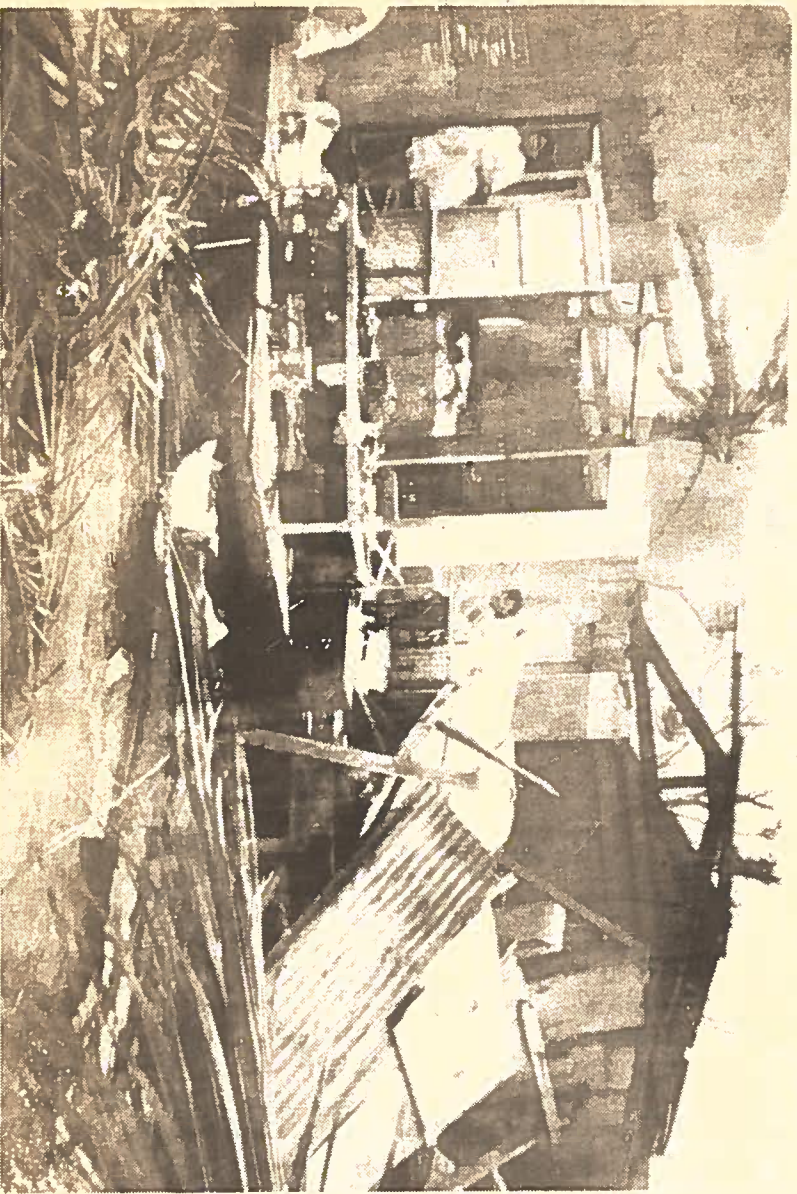


# Gilda Leaves Rota In Shambles



The Trust Territory liaison office located on Guam reports of several efforts being made in behalf of the citizens of Rota, which was ravaged by Typhoon Gilda Monday morning.

High Commissioner William R. Norwood, whose plane was unable to land on Rota Tuesday because of the high winds, had to spend the night on Guam. But Norwood took off yesterday at 10:30 a.m. for Rota in order to provide first-hand assistance.

The effects of Gilda's wind and rain on the island's buildings was extensive; two official from Rota report that better than 80 per cent of the people's homes suffered substantial damage.

The officials, Antonio A'aliig, mayor of the Rota municipality, and Benjamin T. Monglona, a member of the House of Representatives of the Congress of Micronesia, arrived on Guam yesterday to seek the assistance of the Trust Territory Liaison Officer, the U.S. Navy the Red Cross and perhaps Governor Manuel F. L. Guerrero. They

hope to receive construction materials, food and clothing.

The accompanying photograph taken by Mangiona is typical of the after effects of Gilda's fury.

The Trust Territory office reports that Chaplain Clancy of Andersen Air Force Base planned to send an airplane or helicopter to Rota yesterday carrying food, clothing some building materials, and a medical team.

The Trust Territory people are discussing with the U.S. Navy here the possibility of borrowing an M boat (landing craft) for a 30-day period. The vessel would be used to transport supplies from a ship to the shoreline of Rota, which has no harbor facilities.

## Korean Editors Arrive

Editors representing ten newspapers and a wire service in the Republic of Korea arrive on Guam tonight to start a one day tour of military installations here.

The 11 news editors, who are accompanied by two members of the U.S. Seoul Embassy military staff and two members of the U.S. Information Service staff, are on an orientation tour of U.S. military installations in the Pacific. Other areas being visited include Okinawa, Wake Island, and Hawaii.

While on Guam, the newsmen will attend briefings by Fleet Weather Central/Joint Typhoon Warning Center, the staff of Rear Admiral Carlton B. Jones, Commandant of the Strategic Air Command, Third Air Division, Andersen AFB.

### Is Bombed

ROME, (AP)—The explosion of a bomb thrown from a passing car shattered the windows of the Venezuelan Embassy to the Vatican. Police said the crudely fabricated bomb landed on the steps of the building and witnesses reported seeing a group of men rapidly drive off as the bomb exploded into flames.

The bomb, according to police, was not necessarily meant for the Venezuelan Embassy since other embassies, including Pakistan and Germany, are located on the same street nearby.

Police said an investigation into the matter had been opened.

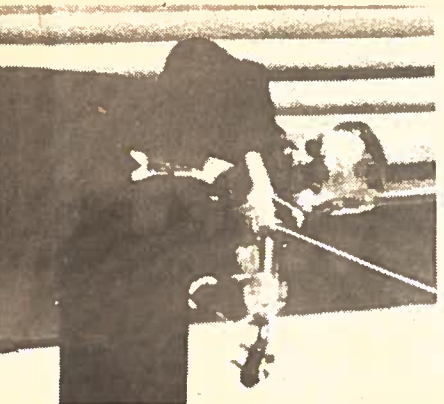

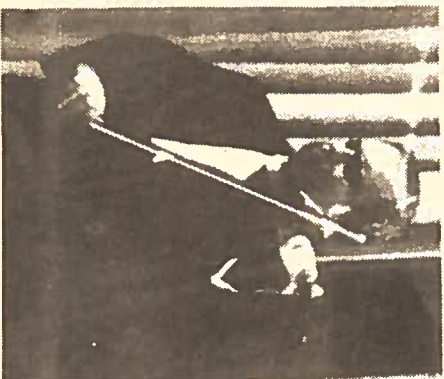

## Shirley Temple Black Loses Cal. Election

Redwood City, California (AP)—Paul N. McCloskey, who won a Silver Star in the Korean war and favors immediate negotiations to end the Vietnam war, defeated former child movie star Shirley Temple Black for the Republican nomination for Congress.

McCloskey, 40, will face Democrat Roy A. Archibald, 47, on Dec. 12 in a runoff election since none of the candidates got more than 50 per cent of the total vote in the 11th Congressional District special election.

With all but 11 of San Mateo County's 575 precincts counted, McCloskey piled up 50, 634 votes to 33,015 for Mrs. Black.

Archibald led his nearest Democratic rival, Edward M. Keating, 14,645 to 8,546.

Archibald favors an "all-out diplomatic offensive to bring about negotiations... We should stop our bombing of the North." Archibald is West Coast representative of the National Education Association.

# Name Micronesian Status Commission

The President of the Senate and the Speaker of the House of Representatives, Congress of Micronesia, have appointed the members of the Future Political Status Commission pursuant to Senate Joint Resolution No. 25, SDI, of the Third Regular Session.

The following Senators and Representatives were appointed to the Future Political Status Commission: Representative Lazarus Sa-

ihii (Palau), Temporary Chairman; Senator Francis Nunua (Yap); Rep. Petrus Malio (Truk); Sen. Bailey Oiler (Ponape); Sen. Amata Kabua (Marshalls); and Sen. Francisco T. Palacios (Mariana Islands).

The powers and responsibilities of the Commission, as prescribed by S.J.R. 25, are the following: to develop and recommend procedures and courses of political education and action; to present such
